§ 1 Duration of the practical work experience
(1) The work experience will be held in the institution stated above and covers 540 hours of work. The agreement covers the period from to

§ 2 Tasks and contents of the practical training

For the practical training semester the following main assignments and contents are agreed upon: (Please specify on a separate sheet)

§ 3 Duties of the host organisation

The organisation will:

- 1. give the student an introduction to his/her assignments.
- 2. specify a qualified person who will be responsible for instructing and supervising the student.
- 3. notify the Public Health Programme if the student fails to begin work or ends the semester internship early.
- 4. write a qualified recommendation for the student after finishing the semester internship.

§ 4 Duties of the student

The student will:

- 1. work conscientiously on the given assignments.
- 2. respect the ethical fundamentals of the institution.
- 3. respect rules and regulations and be careful with given materials, technical and electronic devices.
- 4. act in the interest of the institution and maintain confidentiality about internal processes.
- 5. notify the internship institution immediately if unable to attend due to illness; to present a doctor's certificate on the third day of extended illness.
- 6. write a report about the practical experience semester.

§ 5 Insurance

The intern is subject to compulsory student health insurance during the compulsory internship as an enrolled student, unless he/she is exempt from compulsory insurance due to entitlement to family health care. The same applies to nursing care insurance.

The legal accident insurance from the study relationship applies to the internship relationship (only in the case of internships within the framework of the university or internships that are subject to the university's right of direction);

Apart from that, it is not an activity subject to compulsory insurance, so that contributions to pension insurance and unemployment insurance are not paid.

§ 7 Vacation days

There are no vacation days during the practical experience semester. The host organisation may grant occasional vacation days to the student for personal reasons.

§ 8 Change of institution

Only in exceptional cases and for significant reasons, students will be permitted to change the host institution during the practical experience semester All changes require the approval of the Internship Commissioner of the University of Bremen.

§ 9 Cancellation of this agreement

This agreement requires the approval of the Public Health Programme. During the period preceding the practical training, this agreement may be void if the student fails to meet the academic requirement necessary for entry into the practical experience semester, as specified in the programme regulations. The internship can be cancelled:

- for an important reason without giving notice.
